## Residential Burglary

**Location of Incident:** 4000 block of East County 15th Street – Yuma, AZ

**Update:**

On May 24, 2017 at approximately 8:30 a.m., the Yuma County Sheriff's Office Criminal Investigation Bureau along with the Yuma County Narcotic Task Force served a search warrant at a residence in the 4800 block of West 21st Street in Yuma in reference to numerous burglary cases through-out Yuma County.

While on scene conducting the search of the residence a vehicle of a known associate of the suspect(s) drove by the residence. Deputies attempted to conduct a traffic stop, however; the driver of the vehicle failed to yield to pursuing law enforcement vehicles. The pursuit came to an end in the area of West County 12th Street and South Avenue C when the suspects bailed out of the vehicle and ran from law enforcement officers on foot. With the assistance of the United States Customs and Border Protection Air Operations the occupants of the vehicle were located and detained.

During the search of the residence numerous stolen items including stolen weapons were located.

Suspect 1- Angel Rene Jimenez, 31, of Yuma was arrested and booked into the Yuma County Detention Center on three counts of criminal trespassing, burglary, trafficking in stolen property, theft and one count of criminal damage.

Suspect 2- Ruben Navarro, 30, of Yuma was arrested and booked into the Yuma County Detention Center on three counts of criminal trespassing, burglary, trafficking in stolen property, theft and one count of criminal damage.

Additional suspects have been arrested in connection to the burglaries.

On 05/16/2017, Juan Carlos Arcos-Llamas, 40, of Somerton was arrested and booked into the Yuma County Detention Center for trafficking in stolen property, theft, possession of dangerous drug and possession of marijuana.

On 05/21/2017, David Marquez, 26, of Yuma was arrested and booked into the Yuma County Detention Center on five counts of theft of means of transportation, trafficking in stolen property and burglary.

**Original Release:**

On May 3, 2017 at approximately 9:25 a.m., the Yuma County Sheriff's Office responded to the 4000 block of East County 15th Street in Yuma, AZ in reference to a delayed residential burglary.

Upon arrival, Deputies noticed an open door to a shop near the home. Deputies were able to recover video evidence of the suspects and vehicle used in the burglary. While reviewing the video it was learned that the suspects stole multiple items from inside the shop along with a white and blue trim 19 foot Tahiti jet boat and trailer.

The suspect vehicle is a White 2000's model Chevrolet Tahoe.
