A meeting of the Local Board of the Yuma County Sheriff's Office Corrections Officer Retirement Plan was held Thursday, July 24, 2025, at the Yuma County Sheriff's Office.

Chairman Simmons called the meeting to order at 3:30 p.m.

The board reviewed the minutes of the December 11, 2024 meeting. Mrs. Ogden motioned to approve the December 11, 2024 minutes as presented. Sgt. Sanchez seconded. The motion carried 5 to 0.

Yuma County Chief Financial Officer, Mr. Humberto Del Castillo, presented to the local board, the Yuma County Board of Supervisors Resolution No. 2025-20, Revising the Adopted Yuma County Public Safety Personnel Retirement System (PSPRS) and Corrections Officers Retirement Plan (CORP) Pension Funding Policy (2025). Mr. Del Castillo read section III – Procedures, second and third paragraph of the policy. He explained fiscal year ending June 30, 2026, and the estimated annual required contribution (ARC) is \$342,829 for CORP. Additionally, he reminded that in December of 2020, the BOS approved issuing \$35 million in bonds to fully fund the PSPRS/CORP unfunded liability. Mr. Del Castillo then explained section IV - County's share of assets and liabilities, the County's assets for CORP are \$32.9 million, liability is at 35.8 million, a difference of \$2.8 million, and funding ratio at 92.1%. He further explained the current ratio is very healthy, and if the ratio goes below 80%, then the County needs to reevaluate their financial strategy. He explained the employer rates from FY 2020-21 to FY 25-26. Mr. Del Castillo advised in FY20-21, the rates were 19.12%, after issuing the bonds, the rate decreased to 5.83%. Currently, the rate is 7.83%, a slight increase from the previous year. The increase is due to assumptions (investment returns, employment rates ... etc.). The secretary advised the board per statue the board is required to review, approve, and post the policy every year; the policy has been posted to the County's website. After a review of the presentation, Sqt. Dominquez motioned to approve Revising the Adopted Yuma County Public Safety Personnel Retirement System (PSPRS) and Corrections Officer Retirement Plan (CORP) Pension Funding Policy (2025). Mrs. Ogden seconded. The motion carried 5 to 0.
