Sgt. Thrailkill motioned to approve new PSPRS members. Mrs. Ogden seconded. The motion carried 5 to 0.

**Separated Members:** The secretary advised board members that the following PSPRS members separated employment with Yuma County Sheriff's Office: Cody Walden, date of separation 09/05/25; Hugo Meza Ovando, date of separation 09/11/25; and Klayton Carter, date of separation 11/20/25. **Current Events:** Sgt. Farias advised the board members that the Deputy Academy will be graduating on January 13, 2026, at 1:30 p.m., at Arizona Western College. The Sheriff's Office currently has three (3) recruits in this Academy. Sgt. Farias welcomed all board members to attend. Chairman Simmons asked time frame of the Academy and how many agencies participate? He answered his questions by stating the Academy is 21 weeks long and the college currently has 8 agencies participating.



The next Deputy Academy graduation is in March of 2026, with four (4) recruits currently attending. The next academy will begin in February of 2026. Mr. McDowell asked the ones scheduled to graduate in March, when did they begin the Academy? Sgt. Farias advised they began in November. Additionally, he advised AWC's total training hours is 800 and they are considering adding another 40 hours for Patrol tactics, an increase to what it used to be a long time ago with 545 hours.

The next meeting was scheduled for January 14, 2026 at 2:45 p.m. The secretary advised the reason why she scheduled the next meeting in January instead of June. She informed the local board she received a Disability application. Chairman Simmons asked who submitted the application, the secretary advised August Turner. The secretary advised she will have Disability packets ready for them to review at least one week prior to the hearing/meeting.

Sgt. Farias advised the local board members of the monthly training available on the second Thursday of every month by the Phoenix Office. This month's training is on Disability. The secretary advised she will request the link and will forward to all board members.
