<b>CAUTION: Arizona Revised Statutes § 39-121.03(C) provides:</b>			
<p>A person who obtains public records for a commercial purpose without indicating the commercial purpose or who obtains a public record for a non-commercial purposes and uses or knowingly allows the use of such public record for a commercial purpose or who obtains a public record for commercial purposes and uses or knowingly allows the use of such public record for a different commercial purpose or who obtains a public record from anyone other than the custodian of such records and uses them for a commercial purpose shall, in addition to other penalties, be liable to the state or political subdivision from which the public record was obtained, for damages in the amount of <i>three (3) times the amount which would have been charged</i> for the public record had the commercial purpose been stated, plus costs and attorneys' fees or shall be liable to the state or the political subdivision for the amount of <i>three (3) times the actual damages</i> if it can be shown that the public record would not have been provided had the commercial purpose or actual use been stated at the time of obtaining the records.</p> <p>A commercial purpose is defined by Arizona Revised Statutes as the use of a public record for the purpose of sale or resale, or</p> <ul style="list-style-type: none"> <li>• producing a document containing all or part of the copy, print-out or photograph for sale, or</li> <li>• obtaining of names and addresses for such public records for the purpose of solicitation, or</li> <li>• for any purpose in which the purchaser can reasonably anticipate the receipt of monetary gain from the direct or indirect use of such public records.</li> </ul>
