The board members reviewed FY2018 First Quarter Newsletter of the Public Safety Personnel Retirement System (PSPRS). The secretary reminded the board members that as of July 1, 2018, the Defined Benefit (DB) plan will cease and anyone hired on or after July 1st will be on the Defined Contribution (DC) plan. She further advised employees will contribute 7% and the employer will contribute 5% into the retirement. In addition, the secretary advised the local board members that under the DC plan, a member will be fully vested after three


