Yuma County Chief Financial Officer, Mr. Gilberto Villegas, presented to the local board, the Yuma County Board of Supervisors Resolution No. 2020-25, Revising the adopted Yuma County Public Safety Personnel Retirement System (PSPRS) and Corrections Officers Retirement Plan (CORP) Pension Funding Policy (2020). Mr. Villegas explained the following to the local board members: 1) Adopted Pension Funding Policy; 2) Unfunded liability percentage; and 3) Arizona Counties Unfunded Comparison Sheet. He advised that the pension policy was presented to the Yuma County Board of Supervisors and they approved the policy. He further advised Yuma County was in compliance with the statute. The board members had no questions for Mr. Villegas. After reviewing the policy, Ms. Ogden motioned to accept and approve the Yuma County Resolution No. 2020-25. DO Hand seconded. The motion carried 4 to 0. Mr. Villegas then asked the board if they received PSPRS/CORP Reports from last year. He stated the report has good information and that he can forward the website link to the board. Lastly, he is looking forward to the assessment tool, where he will be able to enter different scenarios and contribution amounts, to determine projected costs.
