Armed Robbery

Location of Incident: 13100 block of E. 41st Lane, Yuma, AZ

Update 2: On Friday, June 25, 2021 at approximately 9:47 AM, YCSO Investigators arrested a third suspect, **Christian Strangfeld**, 20, of Yuma, for the armed robbery that occurred in the 13100 block of 41st Lane on June 18.

Strangfeld was booked into the Yuma County Detention Center for Armed Robbery, Criminal Trespassing, Aggravated Assault, and other numerous charges.

This case remains under investigation at this time.

Update 1: June 24, 2021 – 3:30 PM: On Wednesday, June 23, 2021 at approximately 11:44 AM, YCSO Investigators located and arrested **Korey Gallagher**, 22, of Yuma, and **James Brazil**, 27, of Yuma, for the armed robbery that occurred in the 13100 block of 41st Lane on June 18.


Gallagher and Brazil were booked into the Yuma County Detention Center for Armed Robbery, Criminal Trespassing, Aggravated Assault, and other numerous charges.

Search warrants were served at both suspect's residences where some of the victim's property and firearms used during the crime were located.

Early in the investigation, it was determined to be a targeted incident. It was discovered that one of the suspects was a known party to the victim. Due to the circumstances, initial details provided to the public were limited so as not to hinder the ongoing investigation and integrity of the case.

On Friday, June 18, 2021, at approximately 6:02 AM, the Yuma County Sheriff's Office responded to a report of an armed robbery in the 13100 block of E. 41st Lane.

Deputies were informed unknown suspects entered an occupied residence and demanded some of the victim's property. Once property was received the suspects departed the area. During the incident the suspects displayed firearms.

No injuries were reported. This case remains under investigation at this time.
