## Level 3 Sex Offender Notification Elijah Dale Seybert

**New Address: 27267 Mesquite Avenue – Wellton, AZ 85356**

The Yuma County Sheriff's Office (YCSO) is releasing the following information pursuant to A.R.S. 13-3825, the Community Notification on Sex Offenders Law. The offender in this publication is living within Yuma County. It is the responsibility of the Chief Law Enforcement Office having jurisdiction where the offender resides to make notification to the community. Notification must be made when certain sex offenders are released from the Arizona State Prison, accepted under an interstate compact or released from the county jail back into the community. Offenders are categorized into three levels: Level One (low risk to the community), Level Two (intermediate risk to the community), and Level Three (high risk to the community).

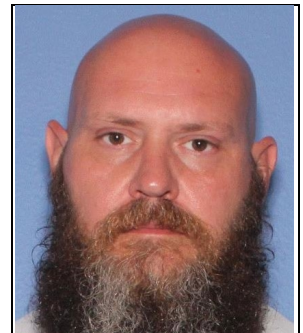
The individual who appears on this notification, **Elijah Dale Seybert**, 42, has been convicted of a sex offense that allows for community notification. Elijah Dale Seybert has advised the YCSO that he is residing at 27267 Mesquite Avenue in Wellton, Arizona. He is described as 6 feet, 4 inches tall, 275 pounds, with brown hair and brown eyes. He is not wanted by the Yuma County Sheriff's Office at this time.

On June 15, 1998, Seybert pled guilty in the Boulder County Court in Boulder, Colorado to one count of Indecent Exposure: under 15. He was sentenced to 18 months of probation and six months of work release, with 90 days credit for time served.

On January 14, 2002, Seybert pled guilty in the Mesa County Court in Grand Junction, Colorado to one count of Indecent Exposure to 15/older, and one count of Harassment—alarm/annoy. He was sentenced to four months in jail.

On September 29, 2017, Seybert pled guilty in the Boulder County District Court in Colorado to two counts of False Information on Registration. He was sentenced to 18 months in jail (concurrent) with 186 days credit for time served. He also pled guilty to one count of Patronizing a Prostitute—Enter Place and was sentenced to 6 months in jail (consecutive).

Elijah Dale Seybert is considered a Level 3 sex offender with a high risk to reoffend.

This notification is not intended to increase fear; rather, it is our belief that an informed community is a safer community. The YCSO has no legal authority to direct where a sex offender may or may not live. Unless court ordered restrictions exist, this offender is constitutionally free to live wherever he/she chooses. Citizen abuses of this information to threaten, intimidate, or harass sex offenders will not be tolerated. Sex Offenders have always lived in our communities; but because of Megan's law, law enforcement is now able to share this information with you.
