## Level 1 Sex Offender Notification **Walter Bryan Altene**

New Address: 13256 E. 52nd Street - Yuma, AZ 85367

The Yuma County Sheriff's Office (YCSO) is releasing the following information pursuant to A.R.S. 13-3825, the Community Notification on Sex Offenders Law. The offender in this publication is living within Yuma County. It is the responsibility of the Chief Law Enforcement Office having jurisdiction where the offender resides to make notifications to the community. Notification must be made when certain sex offenders are released from the Arizona State Prison, accepted under an interstate compact or released from the county jail back into the community. Offenders are categorized into three levels: Level One (low risk to the community),


Level Two (intermediate risk to the community), and Level Three (high risk to the

community).

The individual who appears on this notification, Walter Bryan Altene, 60, has been convicted of a sex offense that allows for community notification. Walter Altene has advised the YCSO that he is residing at 13256 E. 52<sup>nd</sup> Street in Yuma, Arizona. He is described as 5 feet 10 inches tall, 195 pounds, with gray hair and blue eyes. He is not wanted by the Yuma County Sheriff's Office at this time.

On January 21, 2009, Altene pleaded guilty to one count of Sexual Conduct Forcible in the Second Degree (person under 13 years of age) in the Genese County Seventh Judicial Circuit Court in Flint, Michigan. He was sentenced to serve 180 months, serving 85.6 months at the Michigan Department of Corrections. His victim was a female juvenile known to him.

Walter Altene is considered a Level 1 sex offender with a low risk to reoffend.

This notification is not intended to increase fear; rather, it is our belief that an informed community is a safer community. The YCSO has no legal authority to direct where a sex offender may or may not live. Unless court ordered restrictions exist, this offender is constitutionally free to live wherever he/she chooses. Citizen abuses of this information to threaten, intimidate, or harass sex offenders will not be tolerated. Sex Offenders have always lived in our communities; but because of Megan's law, law enforcement is now able to share this information with you.
